

# Minutes of the Springbrook National Users Group Board of Directors Meeting

March 10, 2016 | 8:00 am (PST)

The meeting of the Springbrook National Users Group (SNUG) Board of Directors was called to order on March 10, 2016 at 8:05 am Pacific Time by President-Elect Hubert Wenzel. **Approval of February Board Meeting Minutes:** After review of the previous meetings minutes, a motion was made to accept the February 11, 2016 board minutes as presented. The motion was seconded and unanimously approved.

**User Group Meetings:** Corbeille will coordinate with Barrett and Mancinelli (Accela Rep) to plan a user group meeting in Wisconsin. Corbeille will provide date, time, location and agenda to Barrett for promotional materials.

**Conference:** The Accela Conference is scheduled for August 22 - 26, 2016 at the JW Marriott in Los Angeles, CA. No agenda has been posted.

Wenzel inquired about the SNUG Annual Meeting and board elections. Barrett reported that per the SNUG Bylaws, the board election and Annual Meeting takes place during the Software Conference. This bylaw allows the board terms to be extended until the meeting and vote takes place. Corbeille volunteered to contact Mancinelli regarding the SNUG Annual Meeting taking place during the Accela Conference.
